#### 10. Mosies / Motions

#### 10.1 - Motion by West Coast -

#### West Coast Region Motion competitions

The affiliated members of the region wish to propose a change in the dates allocated for Boland competitions during the hottest months of the year being January and February.

It is proposed that these competitions be moved to November/December or March/April.

#### Motivation

It was decided at the West Coast AGM on the 14 May 2022 to put the motion forward. It is becoming very clear that the temperatures reached during January and February has increased and heat waves during this period is common. We have no guidelines from BSA on the subject, but it seems Sport Associations worldwide are at idem that outdoor sport is dangerous and is prohibited at heat temperatures higher than 32 degrees Celsius. At that point heat fatigue set in and sunstroke is a danger, especially as more than 80% of our bowlers are of the age of 60 years old.

Very few players are able to participate at their top performance level in such heat for the whole day and sometimes two days in a row during play offs. The past January February period we have experienced heat close to 40 degrees Celsius. Rule 33 has implications on forfeiture of a game as we experienced during this hot period.

**10.2** The following changes to the Boland Bowls constitution are proposed by Cape Winelands Bowls as agreed upon as per our Annual General Meeting on 19 May 2022. (Proposed changes in red)

B.3.1 Indien 'n klub nie oor voldoende spelers beskik vir 'n Wynland kompetisie nie, mag daardie klub

van spelers van 'n klub, gebruik maak, mits

\* laasgenoemde klub in Wynland Distrik is en

\* laasgenoemde klub en speler(s) by Wynland geaffilieer is;

\* laasgenoemde klub toestemming verleen; en

\* die betrokke speler(s) nie in daardie kompetisie gedurende die bepaalde seisoen vir enige ander span gespeel het nie.

\* Hierdie toegewing is beperk tot hoogstens twee spelers per span.

B.3.1 If a club does not have enough available players for the Wynland Competitions, that club may make use of players from a club within that players District, provided that \* the latter club is in the Winelands District: and

\* the latter club has granted permission; and

\* the latter club and player(s) are affiliated to Winelands Bowls;

\* the player(s) concerned has/have not played for any other team in the competition during that specific season.

\*\* This concession is limited to two players per team.

## Sake deur die Uitvoerende Bestuur verwys / Matters referred by the Executive By Winelands – Membership of one District only

Wynland vra besprekingspunt: Dat 'n speler slegs lid van klubs in een Distrik kan wees

'Aangaande die grondwet van Rolbal SA wat 'n speler toelaat om 'n volle lid van meer as een klub in enige distrik in SA te wees was die algemene gevoel van die afgevaardigdes tydens Wynland AJV dat 'n speler slegs lid van klubs in een distrik kan wees en dat Boland Rolbal die saak met SA Rolbal moet opneem.

Winelands ask for discussion: **Membership of a bowler should be restricted to one District only** Regarding the constitution of Bowls SA which allows a bowler to be a full member of more than one club anywhere in South Africa, the delegates at the Winelands AGM felt that membership of a bowler should be restricted to one district only and that the matter should be referred to Boland Bowls to take up with Bowls SA.

#### **11.2 BSA Affiliasie fooi beleid / BSA Affiliation fee policy.** By Bowls South Africa Executive.

In terms of paragraph 20.5.2 of Constitution of Bowls South Africa Council is empowered to fix conditions and fees for the membership of Bowls South Africa (Bowls SA).

The Executive wish to propose a change to the current fee structure of payment per registered bowler to the following:

Fees for membership of Bowls SA will be charged annually to each Province who in turn will apportion such charge to each district /club within the area of their jurisdiction. The basis of the determination of this annual charge will be the subject of a policy with regard to this

#### MOTIVATION

Bowls South Africa, on a regular basis, are challenged as to the legality or otherwise of so-called 'casual/social' bowlers rights to access to the bowling greens of affiliated clubs and in terms of current provisions of the Constitutions of Bowls SA, Provincial Bowls Associations, District Associations and Clubs

there exists no provisions that entail the right of any party to restrict the right of any club in allowing clubs to grant access to their greens to persons who are not registered with Bowls South Africa. It is also recognised that giving access to 'unregistered' bowlers provides an ever-increasing important financial stream for clubs and to deny access would, ultimately, be non-beneficial to clubs and by implication Districts, Provinces and ultimately Bowls SA.

Therefore, to create an environment in which the determination of access to greens resides with the proprietors of those greens it suggested we move away the 'so-called' barrier preventing this. The basis of charging a singular fee to those parties who have membership of an Association such as Bowls SA or a body affiliated to Bowls SA is a principle that has been implemented by both World Bowls and Bowls Australia. Effectively by accepting this proposal the onus reverts to clubs to seek revenue to fulfil their right of membership to Districts and Provinces.

The proposal is that a base financial figure is established using the total financial contribution made to Bowls SA by all members affiliated to Bowls SA as at the 31<sup>st</sup> December 2021. This fee will, subject to approval by Council, be subject to annual incremental changes. In as much as Bowls SA have the right to collect this fee from Provincial associations so too will Provinces have the right of collection from District and ultimately from Clubs.

The Executive realise that this is a fairly dramatic move away from tradition but the Executive believes it will see the end of the dispute of entitlement and once clubs realise that the time spent entertaining 'non-members' on their greens will need some form of compensation to allow them to make up revenue collection for 'affiliation fees' and indeed may even open the way for more aggressive marketing and membership recruitment. In addition, by following this route long term sustainability of Bowls SA, Provinces and District becomes more secure.
